Work Package 2 (WP2) - Human Capacity Building in Public Health Education in Montenegro was aimed on organizing training, workshops, networking, good practice exchange, all moving towards: (i) helping staff members from Montenegro (ME) higher education institutions (HEIs) to enhance their expert knowledge in public health by sharing evidence-based public health teaching models of innovation and good practice; respecting the diversity of national and European population health challenges and threats, as well as on (ii) increasing the visibility of ME HEIs staff members and participating institutions' profiles in international teaching community in the interdisciplinary area of public health.

- Activity 2.2 (Deliverable 2.2 Report: Teaching Competencies Development of academic staff from Montenegro) – Planning and organising training activities for Montenegrin staff members in different fields of public health
- Activity 2.3 (Deliverable 2.3 Report: Strengthening cooperation with EU authorities in healthcare education)

Both activities are implementing successfully, as follows:

- Implementation of the Activity 2.2. started with creating working groups within 4 multidisciplinary fields. Each WG is led by experienced EU partner iniversities, with partiicpantion of staff members from Montenegrin academic and non-acadeic partner institutions. Unified template for WG staff memberes' CVs are prepared.
- Training events plan is prepared by following plan proposed in the project proposal, and making slight modifications: Zero training as intrductory is proposed; organisation of joint training events in Monteengro for wider audience, etc.
- All activities were carried out according to plan, with active participation of all partner institutions.

- In addition to project proposal, Distance Leraning plratom is launched for the purpose of training events (and will be used later also for teaching process at ME HEIs).
- Evaluation approaches are carefully selected and includes: (i) standard questionnaires with 8 closed and 4 open questions (integrated within developed platform), and additionally (ii) self-regulation approach as recently developed and used for adults education.
- Implementation of the Activity 2.3. started with reviewing exising situation in Montenegro, understanding the level of expertise of MNE staff mebers, and creating action plan within 4 thematic groups. Major progress in made in the field of Medical informatics, whie results in other groups are expected for upcoming period.

Work Package 3 (WP3) - Analyses of educational programs in Public Health was aimed on making detailed analyses of existing educational programs in ME related to public health interdisciplinary fields; creation of enhanced programs/courses/curricula in public health in ME (including all levels- from undergraduate to PhD programs); creation of at least 1 new program (MSc in public health economy and management at UDG); accreditation of new program and formal integration of updated courses/programs into the curricula; preparation of learning repository in Public Health (teaching and learning materials, National Platform for Education and Research of Public Health in Montenegro, etc.). Thus, the following activities were planned and carried out for reporting period:


- Activity 3.1 (Deliverable 3.1 Report: Analysis of EU practice for public health)
  The goal of the report was to facilitate understanding and transparency regarding current and future courses/programs on public health at the University of Montenegro, University of Donja Gorica and University Mediterranean.
- Activity 3.2 (Deliverable 3.2 Report: Creation of new and updated programs and courses curricula) Creation of new MSc program, and all other courses/curricula which will be implemented at all 3 partner universities.
- Activity 3.4 (Deliverable 3.5- Integrated new/updated courses into the curricula of ME partner HEIs) Formal verification of developed courses and integration at extsing study programs. It could require either formal decisions by Educational and Scientific Boards (as Faculty/University level)- only for small changes or accreditation procedure for bigger changes.

Due to decision of the Quality Control Board, both activities started earlier for University of Montenegro (due to re-accreditation process), and their progress is as follows:





- Implementation of activity 3.1- The comprehensive analysis including information on subjects, technical background and staff. University of Montenegro has provided information on public health and medicine, University of Donja Gorica on Health Economics and Management and University Mediterranean on Public Health Law. Information was collected by a survey consisting of 11 questions. The questionnaire was developed by the University of Debrecen.
- Implementation of activity 3.2- One new MSc program "Helath Information Management" is drafted as well as sets of courses, as follows:
  - University of Montenegro:
    - Medical faculty with 5 study programs: medicine, dentistry, pharmacy, nursing and physiotherapy: 1.cycle (I-VI semester): 8 courses; 22 ECTS; 2.cycle (VII-XII semseter): 6 courses; 18 ECTS; 3.cycle: renewed PhD program
  - University of Donja Gorica:
    - Faculty for International Economy, Finance and Business (BSc- 1 course; 5 ECTS; MSC- 2 courses; 10 ECTS)
    - Faculty for Infomration systems and technology (BSc- 2 courses; 14 ECTS;)
    - Faculty for Culture and Tourism (3 new modules at BSC and MSc levels)
    - Faculty for Sport Management (2 new modules at BSC and MSc levels)
    - Faculty of Law (MSC- 1 course; 5 ECTS)
  - University Mediterranean:
    - Faculty of Law (BSc- 1 course; 5 ECTS; MSC- 2 courses; 10 ECTS)
    - Faculty for Business studies (BSc- 4 course; 24 ECTS; MSC- 6 courses; 38 ECTS)
- Implementation of activity 3.4- University of Montenegro completed process of formal integration of crated courses as a part of university re-accreditation. University of Donja Gorica and University Mediterranean will do the same in 2018/2019 when universities' accreditations are scheduled.
